- **Accessibility:** Building systems and structures that make the Secretariat responsive to all members, regardless of cadre, age, or location.





# 1. Smart & Tech-Driven Secretariat

In this era of rapid technological advancement, I am convinced that the future of our Branch lies in our ability to embrace and deploy smart, efficient technology. A forward-thinking Secretariat must empower members with seamless access to information, enable efficient interaction with the Branch, and ensure that participation in events and activities is easy, regardless of location.

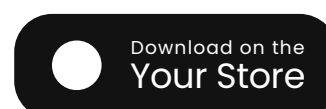
As a legal practitioner deeply passionate about legal technology and emerging innovations, I am committed to transforming the Secretariat into a smart, technology-driven, service-oriented engine room of the NBA Lagos Branch. I will during my term:

- Deploy up-to-date technological tools to enhance administrative efficiency and streamline Secretariat operations.
- Launch a secure and accessible online membership database, enabling real-time communication, targeted information sharing, and member verification when needed.
- Develop and deploy a modern, user-friendly Branch website that reflects the evolving needs of members, serving as a one-stop hub for circulars, notices, event updates, committee activities, and Secretariat documents.

- Introduce Artificial Intelligence (AI) innovations, including smart chatbots and automated service assistants, to help members engage the Secretariat 24/7, access frequently requested documents, and receive quick responses to enquiries.
- Launch a dedicated Branch mobile app to make communication, access to circulars, registration for events, payments and participation in Branch activities easier and faster on the go.

Furthermore, I will ensure the effective implementation of the recommendations contained in the Branch's existing IT report and introduce additional measures to strengthen our digital infrastructure, especially concerning data protection, system resilience, and user-friendliness.

Through these initiatives, we will reposition the Secretariat as a model of innovation and efficiency, ready to meet the demands of a fully digitalised bar and lead by example within the Nigerian Bar Association.



## 2. Enhanced Service Delivery and Communication with Members



One key area that requires urgent intervention is the application and collection of the NBA stamp and seal. As Secretary, I will work to significantly reduce the difficulties our members currently experience in this process by simplifying, modernising, and improving the system.

Working collaboratively and liaising strategically with the NBA National Secretariat, which oversees the production of stamps and seals, I will:

- **Push for the Integration of a Real-Time Tracking System:** I will advocate for the introduction of a tracking feature (similar to those used in delivery services), enabling members to monitor the progress of their stamp and seal applications from submission to dispatch. This feature can be integrated into the proposed NBA Lagos Branch mobile app or web portal, making the process less cumbersome and stress-free.
- **Advocate for Priority Handling for Lagos Branch Members:** Given our Branch's size, prestige, and the high volume of applications we process, I will strongly advocate that the NBA National Secretariat prioritise and allocate dedicated resources for prompt processing and dispatch of our members' stamps and seals.

## **Timely Information Update**

- Members deserve timely and accurate communication from the Secretariat. I will implement a clear communication calendar that ensures early notice of meetings, publication of minutes, publication of action points within five days after branch meetings, and dissemination of circulars in a consistent manner.
- Multi-platform dissemination (Email, WhatsApp Broadcast, SMS, Telegram, etc.) will ensure wider and more inclusive reach.

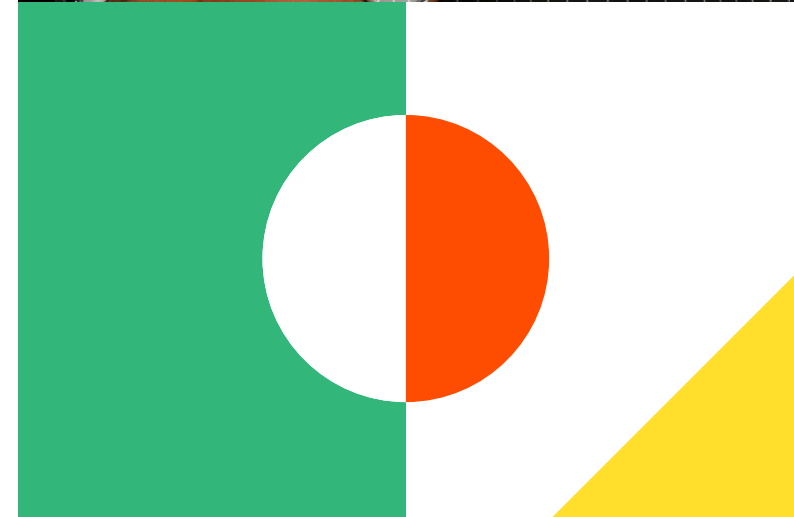
## **ID Card**

I will liaise with the other members of the Exco to reduce the wait-time for production and delivery of membership ID cards. With the approval of the EXCO, we will reduce the number of cards per batch, thereby reducing the time from application to collection. The tracking feature will also be implemented for the cards.



# 3. Advocacy, and Service

- As the voice of the legal profession, the NBA has a responsibility to advocate for our members and the wider society. I will work with the Branch Executives to identify key issues affecting our members and advocate for policies that promote the welfare and interests of lawyers in Lagos branch.
- I will ensure that NBA Lagos Branch is robustly and actively represented at National Executive Council (NEC) meetings, working with the Branch Chairman and other NEC members to articulate and defend the interests of our Branch, ensuring that the Premier Bar remains at the forefront of national discourse and decision-making.
- I will develop a Secretariat Handbook to serve as a guide for subsequent officers, Committee Secretaries, and members handling documentation roles, thereby building a culture of consistency.



## MY EXPERIENCE AND COMPETENCE

- I bring to this race years of active service within the NBA Lagos Branch and the wider legal community, having served on multiple committees, including Human Rights, Annual Law Week/Conference, Annual Dinner, SBL Conference Planning, and being involved in several professional development initiatives.
- As a legal practitioner with strong roots in technology, I have led and advised on legaltech, tech law and have been involved in administrative automation projects for law firms and legal institutions, including our branch.
- I also bring with me previous experience as a documentation specialist and administrator, in different organisations with tested capabilities in correspondence, reporting, planning, and legal record-keeping.
- Above all, I have a passion for systems, structure, and service values I intend to bring fully to the Secretariat.
